Connectivity is a key theme in the EU's relations with Asia, particularly given China's Belt & Road Initiative (OBOR/BRI). This series of roundtables (RT) on connectivity is part of the Asia-Pacific Research and Advice Network (#APRAN) and is organised by #APRAN consortium member Clingendael in cooperation with BusinessEurope and the European External Action Service. It aims to further the exchange between a selected group European business representatives and EU policymakers from diverse sectors and backgrounds **to provide a forum for frank exchange and a fuller and more coherent perspective on connectivity** to stakeholders about bankable opportunities, risks and conditions.

The 1<sup>st</sup> #APRAN Roundtable on 12 September will bring together about 10 selected representatives from European companies with their counterparts in EU policy-making ("RT members"). The discussion will be moderated by Clingendael and will take place under the Chatham House rule. The focus topic for this first, introductory meeting is **"Risks and Opportunities of BRI for European Business"**.
